JOB DESCRIPTION

SciencesPo

The Law School at Sciences Po (Paris) is seeking to appoint an Associate Professor in European Law, position beginning on the 1st of January 2025 (at the latest).

The post holder will contribute to the intellectual life of the Law School through engaging in high quality teaching fostering a supportive environment for students, and participating actively in the wider activities of the School and the Sciences Po academic community.

The candidate should demonstrate the ability to produce outstanding quality research in the field of EU law while engaging in contemporary debates on EU law scholarship and its critiques. She or he should be able to go beyond the traditional institutional understanding of Europe and of its law, carrying out thorough analyses of substantive parts of European law (we are particularly interested in candidates carrying research in areas such as EU environmental law, labour law, citizenship law, criminal law, migration law, economic law, external relations law, health law, constitutional or institutional EU law). Candidates should be willing and capable to mobilise sophisticated legal tools and methodologies, in a multidisciplinary, critical and reflexive perspective, engaging with social sciences and the humanities. They should demonstrate an excellent track record in research, teaching and academic citizenship, as well as international experience and recognition. The candidate must also possess good knowledge of the professional networks crucial to their subjects.

The candidate must hold a PhD in Law or its research equivalent. We are preferably looking for tenured professors at a mid-career stage.

Ability to teach in English is essential, and knowledge of French would be an asset in a bilingual academic community.

Sciences Po is an equal opportunity employer, and is committed to diversity and a balanced gender, geographical, and minority representation. We particularly welcome applications from women.

FUNCTIONS

Research

The successful candidate will conduct their research program at the Law School, by integrating it into national and international research networks, by actively participating in collective events at the Law School (seminars, supervision of doctoral candidates, various collaborations, etc.), and by contributing to the editorial activities of their discipline.

In connection with his/her participation in the activities of the Law Department and the Law School, the candidate will demonstrate an ability to apply for research funds, to develop cooperation with partners outside Sciences Po, as well as to design and lead high-level training projects and individual and collective research projects.

Teaching

Annual teaching duties are 128 master class equivalent (CM) hours that can be divided into three 24-hour master classes and 56 CM hours of complementary pedagogical services at the three levels of teaching offered by Sciences Po: college (on one of the seven Sciences Po campuses), Master's (within one of the seven professional schools of Sciences Po), and doctoral studies.

Candidates must demonstrate their ability to teach foundational and advanced courses in an innovative manner, as well as their willingness to supervise doctoral theses. Candidates will be expected to teach in English and French.

Management and administration

The candidate(s) will contribute to the management of existing programs as well as the creation and management of new educational programs at the Law School.

- 3 major publications;
- A synopsis of 2 potential courses in EU law that the candidate might teach (at Bachelor and Master level) and, if possible, student evaluations of courses already taught;
- A description of the research the candidate intends to carry on if recruited at Sciences Po (max 3 pages);
- Names of three referees who could be contacted by the recruitment committee.

All applications will be examined by the Selection Committee to pre-select 3-4 candidates who will be invited to present their research work at a Job talk at Sciences Po to the academic community.
