MADHUR ANAND



Professor, School of Environmental Sciences, University of Guelph; Director, Global Ecological Change & Sustainability Laboratory

Dr. Anand is a former CRC in Global Environmental Change with a research program centred on climate change impacts and adaptation at local and global levels for ecosystems and human livelihoods related to ecosystem services. As the 2020 recipient of the Governor General's Literary Award for Non-Fiction, Dr. Anand recognizes the power of climate change communication/storytelling to address cultural norms that perpetuate the crisis. She is currently leading a proposal for the NFRF program.

PIA BAILLEUL

Post-Doc Researcher, Center for International Studies (CERI), Sciences Po

Dr Bailleul's work lies at the crossroads of mining anthropology, Arctic studies and science and technology studies. As part of her doctorate in anthropology, defended at the University of Nanterre in 2022, she studied the historical evolution of the legal and social framing of soils and subsoils in Greenland, as well as the associated political issues. She specialises in the social and legal construction of mineral resources and the relationship between global warming and extractive development in the Arctic.

PIERRE CHARBONNIER

CNRS Research fellow, Center for European Studies and Comparative Politics (CEE), Sciences Po

His work focuses on the relationship between the social sciences (anthropology, sociology and history) and environmental issues. He is now examining the adaptation of social protection systems to the economic consequences of the response to the climate crisis, while at the same time studying the relationship between the peaceful balance between world powers and the threat of climate change.

GABRIEL EIDELMAN

Assistant Professor, Munk School of Global Affairs and Public Policy, University of Toronto; Director, Urban Policy Lab

His research focuses on cities and intergovernmental relations in Canada and North America. His courses focus on urban politics, policy, and governance in both the Master of Public Policy and Master of Urban Innovation programs.

CHARLOTTE HALPERN

Researcher, Center for European Studies and Comparative Politics (CEE), Sciences Po Director, Institute for Environmental Transformations, Sciences Po

Dr Halpern is a specialist in comparative public action. Her work focuses on transformations in public action, analyzed from a comparative perspective, mainly in Europe (United Kingdom, France, Germany and European Union) and in South America (Peru), and at the crossroads of three perspectives: the Government and public action, political and social conflicts and the evolution of the State-market relationship.



MILIND KANDLIKAR

Professor at the School of Public Policy and Global Affairs, University of British Columbia

Dr. Kandlikar's work focuses on the intersection of technology innovation, human development and the global environment. His current projects include cross-national comparisons of regulation of agricultural biotechnology; air quality in Indian cities; risks and benefits of nanotechnology; new technologies for sustainable transportation; and development and climate change. He is the former Director of the Institute for Resources, Environment and Sustainability (IRES).

DIANA LEWIS

Assistant Professor, University of Guelph, Canada ; Research Chair for Indigenous Environmental Health Governance ; Director, IndigenERA Lab

Dr. Lewis' research interests are to foster a wider understanding of Indigenous worldviews and how Indigenous worldviews must inform environmental decisions, specifically as Indigenous peoples are impacted by resource or industrial development. She is a strong advocate for Indigenous data sovereignty and Indigenous-led decision making, and she is currently working with Indigenous communities across Canada to develop an Indigenous-led environmental health risk assessment approach.

GIACOMO LUCIANI

Professor, Scientific advisor to the Master in International Energy Transitions, PSIA, Sciences Po

Senior Advisor to the Gulf Research Center and in this context serves as the Team Leader in the EU-GCC Clean Energy Network Project. He is actively involved in the POLINARES FP7 research project. He is editor of the recently released Handbook of International Energy Economics and a member of the Oxford Energy Policy Club, the Geneva Petroleum Club, and the Energy, Oil and Gas Club of the Institut Français du Pétrole (IFP)

ELEANOR MORRISON

Faculty member, Sciences Po, PSIA; Financial Risk and Technology Executive, TD Securities

She has worked in the banking sector (Goldman Sachs, Lehman Brothers, TD Securities), the utility sector (BC Hydro) and in a technology start-up environment (mobile banking).
